### Recommendations for sending these messages:

1. Send the message on **Thursday, June 25th**. Some edits may be made before then, so check back for the most up to date version if you can. If you don't see this before then, send the message as soon as possible after.
2. Send the message to **both** your town's police department and the State Police troop covering your county.
3. **Share widely!** The more people making a coordinated request, the more powerful it will be. Anyone, anywhere can use this template to contact their police departments, not even just people in the North Country. That is our current target audience, but there is no reason others can't use it.
4. You are welcome (even encouraged) to make any changes to the message you want, but consider these thoughts first:
  - a. Personalized messages are probably more powerful, so I actually encourage changing things. However, I think it is important to stay on the specific message of transparency and posting policies publicly.
  - b. **A unified message is powerful, and this is only a first step.** I intend this to be the first in a series of coordinated messages sent to police departments/town governments in the area. Future messages will include specific policy reforms that we request as a group (e.g. choke hold ban, use of force continuum and reporting, redirecting of funds to non-police first responders like social workers). Consider waiting to make major policy requests until we do so as a group.
  - c. We want to be taken seriously, and not seen as aggressors. It's my belief that most police departments in the area will react better to a gradual increase in pressure. If we start with "defund the police," I think we will be dismissed out of hand, and future requests will have less power. Defund the police is my eventual goal, and I think this is the way to get there. You are welcome to disagree with this approach and use this template in taking a stronger initial stance.
  - d. I wrote respectfully on purpose. Yes, we are angry. Yes, it is absolutely ridiculous that police should expect a respectful tone in response to years of

literal killings. However, and this is my opinion again, I think it will be more effective to initially approach departments respectfully. Again, if you disagree you are still more than welcome to use this template to write a less respectfully toned message.

5. **Proofread!** **Fact check!** I quite likely made some typos that I didn't catch. There were also some towns where I wasn't confident about who their police chiefs are. Please let me know and I can fix them or make you an editor so you can.
